Additional Information

The purpose of proposed By-law No. T-7.42 is to add Northumberland Street, Westmorland Street, Carleton Street, Saint John Street, and Church Street (between George Street and Charlotte Street) to Schedule A as Residential Parking Permit Areas and allow virtual payments for each street. The amendment will also add Northumberland Street, Westmorland Street, Carleton Street, Saint John Street, and Church Street (between George Street and Charlotte Street) to Schedule B as Residential Parking Permit Areas and allow daily permit or annual resident parking permits and allow for the purchase of daily permits in the Regent Street Carpark. The housekeeping amendment will add a new subsection under Repeal Provisions.

BE IT RESOLVED THAT the Council of the City of Fredericton hereby authorizes that Bylaw No. T-7.42, A By-law to Amend By-law No. Z-5, A Zoning By-law for the City of Fredericton, be read by summary pursuant to Section 15(4) of the Local Governance Act.

WHEREAS municipalities may make by-laws pursuant to the *Local Governance Act*; and City Council has authorized the reading of By-law No. T-7.42, by summary;

BE IT RESOLVED THAT the Council of the City of Fredericton hereby reads a summary of the by-law as follows: The purpose of proposed By-law No. T-7.42 is to add Northumberland Street, Westmorland Street, Carleton Street, Saint John Street, and Church Street (between George Street and Charlotte Street) to Schedule A as Residential Parking Permit Areas and allow virtual payments for each street. In addition, the same streets will be added to Schedule B as Residential Parking Permit Areas. Daily permit or annual resident parking permits will be allowed and daily permits may be purchased for the Regent Street Carpark. A new subsection under Repeal Provisions is also included as part of this by-law amendment; and THAT the said by-law be given third reading by title.
