## **DISCUSSION**

**Environmental impact**: The City of Fredericton is regulated to provide safe drinking water and safe processing and treatment of effluent from our City's water and wastewater facilities. Operational and capital decisions are all based on keeping the drinking water clean and the negative environmental impact of operations to a minimum. Many capital projects are intended to move the City forward on the Climate Plans and support the City adaptation and mitigation efforts in relation to climate change.
