# Amendments to By-law R-6, A By-law to Regulate Taxi Owners and Operators in the City of Fredericton

BE IT RESOLVED that the Council of the City of Fredericton directs the Legal Division to amend By-law No. R-6, A By-law to Regulate Taxi Owners and Operators of the City of Fredericton as follows:

- 1. By moving the following four sections from section 5 Duties of a Taxicab Driver, to section 11 Prohibitions:
  - 5.02 A taxi driver, while engaged in the operation of a taxicab, shall be neat and clean in appearance and, without limiting the generality of the foregoing, shall not wear any sleeveless shirt, or any clothing with patches therein or any clothing containing advertising logos or slogans other than logos or slogans of the individual, corporation, partnership or association employing the taxicab driver.
  - 5.03 A taxicab driver shall keep their taxicab driver's license in plain sight at all times.
  - 5.04 A taxicab driver shall not use abusive, insulting or obscene language.
  - 5.06 No taxicab driver shall pick up additional passengers, other than in the circumstances of a shared ride or combined ride.
- 2. By including those additions to section 11 Prohibitions, to Section 15 Offences.

#### Pride Festival 2022
