Councillor LeBlanc further questioned if there was any limit to how many Airbnbs could be in operation? Mr. Battilana responded that there is no limit. Councillor Ruth Breen questioned if Applicants that go through the Planning Advisory Committee are asked to provide details around use and whether or not it is a short- or long-term development proposal? Marcello Battilana, Assistant Director of Planning & Development responded that yes applicants are questioned on details and long-term plans; however, presently there is no legislation in place to prevent these types of Airbnb developments.

MUNICIPAL FINANCE & CORPORATE ADMINISTRATION COMMITTEE REPORT

Supplier Code of Conduct

Moved by: Councillor Henri Mallet Seconded by: Councillor Jocelyn Pike

BE IT RESOLVED that the Council of the City of Fredericton hereby approves and authorizes the adoption of the attached Supplier Code of Conduct which sets the minimum standards of suppliers and their subcontractors who participate in the City's procurement process or are selected to provide goods or services to the City of Fredericton.

On the Question:

Councillor Margo Sheppard noted that the City also has a procurement policy that is currently under review as it is 8 years old. She asked that in the course of the review that staff determine, if like Charlottetown, Fredericton can adopt procurement best practices and also study what reasonable steps could be taken to lead us to these best practices. Deputy Mayor Greg Ericson inquired if staff could report back over a period of time on how the Code of Conduct is functioning as there are certain expectations of it. Michael Baldwin, Director of Corporate Services advised that staff would report back on the progress of the Supplier Code of Conduct, as well as, the progress of the procurement policy.

COUNCIL-IN-COMMITTEE REPORT

NB Power's Plug-In NB Charging Rebates Initiative

Moved by: Councillor Kevin Darrah **Seconded by:** Councillor Margo Sheppard

BE IT RESOLVED that the Council of the City of Fredericton hereby approves and authorizes the Participation Agreement between the New Brunswick Power Corporation and the City of Fredericton with respect to the Plug-in NB Charging Rebates for Business Rebate Initiative for the installation of electric vehicle charging infrastructure in public places; and

BE IT FURTHER RESOLVED that the Mayor and City Clerk are authorized to execute the Agreement on behalf of the municipality and such further legal documents as may be required to facilitate the Agreement and this resolution.

On the Question:

Councillor Bruce Grandy noted that he doesn't believe this is a good deal for the city and he has concerns with the City's investment of \$250,000.00. Councillor Grandy indicated that he also doesn't agree with the business case for this project.

Councillor Margo Sheppard indicted that this project is less than ideal because it comes in the absence of an electric vehicle strategy; however, it is a start in the right direction as electric vehicles will soon be everywhere.

Councillor Steven Hicks advised that he would not be supporting this motion as he doesn't believe it is good value for the taxpayers. He noted that the project is for visitors as most residents would charge their electric vehicles at their homes.

Councillor Ruth Breen noted that charging stations are being installed everywhere and as a responsible government, we need to do this project.

Councillor Jason LeJeune inquired if the installation of the charging stations at the current sites allows for more charging stations to be installed in the future. Sean Lee, Assistant Director of Engineering & Operations advised that the project does have embedded costs that cover the capital cost of installation that will be leveraged in the future if further stations are required at the same locations.

Deputy Mayor Greg Ericson inquired as to what the return would be to the city from the use of the charging stations and if they would ever pay for themselves. Sean Lee, Assistant Director of Engineering & Operations advised that the amount is unknown as this is relatively new. Mr. Lee explained that the charging stations are more about providing a service than a revenue source to the city.

Mr. Lee explained that the charging stations being installed are level two chargers that take approximately 7-8 hours for a full charge. He noted that the fast-charging stations are currently not available and cost in the \$100,000.00 range each.

ECONOMIC DEVELOPMENT COMMITTEE REPORT

Adoption of 2023 Implementation Plan – Fredericton Affordable Housing Strategy

Capital Region Service Commission (RSC 11) Update

Her Worship, Mayor Kate Rogers advised that she attended the October 4th, 2022, RSC 11 meeting in Deputy Mayor Ericson's absence. She noted that the budget was reviewed and that there continues to be a lot of unknowns because of the transition period related to the municipal reform. Mayor Rogers noted that one positive from the meeting was that a motion was passed to proceed with the design phase of the regional aquatic centre.

Comments from Mayor and Councillors

Councillor Margo Sheppard advised that the Preservation Review Board met on this date, October 11, 2022, with the Consultant to commence the review of the Heritage Preservation program. Councillor Sheppard indicated that between now and the end of November 2022, the Consultant would be hosting a public meeting with stakeholders for their input and then a report would come

back by the end of January 2023 with the finding and recommendations for a Heritage program for the City of Fredericton.

Her Worship Mayor Kate Rogers advised that the Public Safety open houses/information sessions were well attended and lots of great information was gathered. She noted that another session would take place in November with businesses. Mayor Rogers thanked residents for attending and for voicing their concerns.

Deputy Mayor Greg Ericson requested that a report of the findings from the open houses be presented to Council, as well as the results gathered from Communications Staff from residents as they exited the open houses on the quality of the engagement process. He noted that it was not the normal Town Hall meeting and format, and he would be interested to know how well it was received by the attendees. Steven Hart, Chief Administrative Officer advised that a report would come back following the meeting with businesses, providing feedback to Council.
