Title: Police Contract (UBC 911)

Description:

Council-in-Committee, at its session held on November 28, 2022 considered an administrative report from the Deputy Chief Administrative Officer which requested Council approval and authorization of the Memorandum of Understanding between the City and the Fredericton Police Union (UBC 911)

The City of Fredericton has six workforce bargaining units: Outside workers (CUPE Local 508), Inside Workers (CUPE 1709), Transit workers (CUPE 1783), Professional/technical workers (CUPE 3864), Fire (IAFF 1053) and Police (UBC 911).

UBC represents 104 employees in 2022 and 110 in 2023 (108 approved and 2 over compliment). The remaining employees in the department are non-bargaining or part of other unions. The current Collective Agreement with Police (UBC 911) expired at the end of December 2020. Negotiations spanned 12 days in June, August, September, October and November using interest-based negotiations.

The negotiation teams have tentatively agreed to the attached Memorandum of Agreement (MOA) which highlights the changes in the collective agreement with UBC 911. The MOA requires Council approval and the authorization of Mayor and City Clerk to sign the collective agreement. Below are highlights of the Memorandum of Agreement:

- Term 4 years, January 1, 2021 December 31, 2024.
- Addition of Family Day and Truth and Reconciliation Day to statutory list of holidays
- Definition of immediate family changed to be more inclusive
- Addition of Domestic/Initiative/Sexual Violence Leave
- Changes to the promotional process
- New approach to training.
- Increase in Benefit Spending Allowance (BSA) as per the table below:
