**RE: Priority Allocation for Your Municipality from the Rapid Housing Initiative**

I am pleased to inform you that your municipality has been identified for immediate funding to create new permanent affordable housing under the Rapid Housing Initiative (RHI), for which additional funding was announced in Budget 2022.

Given the large number of applications received, the Government of Canada is investing an additional \$1.5 billion for the Rapid Housing Initiative (RHI). The funding will be divided into two streams as follows:

- \$500 million allocated directly to 41 pre-determined municipalities (Cities Stream), and
- \$1 billion to be allocated under the Projects Stream for eligible applications through an application window that will remain open for a period of approximately 90 days.

As part of the Cities Stream envelope, your municipality has been identified for funding of \$5,000,000 to create a minimum of 17 units of new permanent affordable housing. Please keep this allocation confidential and do not release it publicly until a joint announcement has been made with your Municipality and our Minister.

While the parameters for this round of RHI are largely the same, I would like to highlight the following changes and important information that will be critical to successfully implementing your Cities Stream allocation:

- CMHC will enter into agreements with municipalities first and agree to proposed projects later. We understand this sequencing may pose challenges for municipalities, especially those coming out of an election cycle. Your collaboration to execute an agreement quickly is needed for the funding to be committed and disbursed before the end of the fiscal year 2022/2023.
- CMHC will enter into agreements with municipalities based on minimum unit achievement requirements. Each municipality's minimum unit requirement was calculated according to the proportion of overall funding received under the Cities Stream to achieve an overall target of 1500 units. Funding will be transferred to your municipality in full upon the successful execution of an RHI agreement.
- Once agreements are signed and the application window opens, Municipalities will have approximately 90 days to submit their proposed projects through CMHC's online platform. CMHC will aim to review all proposed projects within 60 days of the submission deadline. Once proposed projects have been approved, they will be added to the RHI Agreement through an amendment.
- CMHC continues to listen to stakeholder feedback and improve on lessons learned from the first two rounds of funding. For this round of RHI, projects proposed by Municipalities will now have up to 18 months (24 months in the North) from the date their projects are approved to reach occupancy. This additional 6 months will provide municipalities more time to adapt to the challenges arising from the current construction climate.
- As CMHC standardizes its energy efficient criteria across all its programs, new construction projects in this round of RHI will now be required to meet energy efficiency standards as set out in the 2017 National Energy Code for Buildings (NECB) for

Part 3 buildings and the 2015 National Building Code (NBC) for Part 9 buildings, as applicable. This is a deviation from previous rounds of RHI that were evaluated against the higher of the 2015 NECB or the local/regional standard.

- As was the case with the second round of RHI, at least 25 per cent of RHI funding will go towards women-focused housing projects, including under the Cities Stream. As well, CMHC continues to ask that municipalities work with Indigenous-led organizations to target 15 per cent of funding for urban Indigenous peoples. To increase the overall impact of RHI funding, we encourage all partners to take a community benefits approach when implementing projects.

Your municipality will also be able to apply under the Projects Stream should you have projects in excess of your allocation received under the Cities Stream. In such cases, projects will be prioritized in a competitive process with all other applications received under the Projects Stream.

Further details regarding updated RHI criteria, timelines, and process to submit your proposed projects for the Cities Stream and, if applicable, submit projects to the Projects Stream, will be shared soon. As imminent next steps, CMHC will be hosting a multilateral call on November 15 with all municipalities under the Cities Stream and an RHI Webinar for all eligible applicants on November 16 for which invitations will be sent shortly. Once you receive these invitations, I would ask that you immediately forward them to the key contact(s) on your team that will be leading the implementation of your RHI allocation. I understand this is very short notice; however, these events will provide important information to help coordinate with your municipality in rapidly delivering housing to the most vulnerable in your community.



I was pleased that other orders of government provided financial support for projects under the first two rounds of RHI. The results achieved would not have been possible without the support of the provincial, territorial, and municipal governments as well as Indigenous governing bodies. I look forward to continued collaboration between all orders of government.

We look forward to working with you to help address urgent housing needs of people and populations who are vulnerable.
