NOW THEREFORE, BE IT ENACTED by the Council of the City of Fredericton, and pursuant to the authority vested in it by the *Local Governance Act*, SNB 2017, c. 18 as follows:

- 1. By-law No. W-3, A By-law Respecting Water Rates and Sewer Rentals, is amended by repealing reference to quarterly service charge of "\$61.90" in subsection (1) of Section 2.02 thereof, and replacing it with "\$67.50"
- 2. The said by-law is further amended by repealing reference to commodity charge of "\$0.97" in subsection (2) of Section 2.02 thereof, and replacing it with "\$1.00".
- 3. The said by-law is further amended by repealing reference to quarterly flat rate commodity charge of "\$67.96" in subsection (3) of Section 2.02 thereof, and replacing it with "\$74.76".
- 4. The said by-law is further amended by repealing reference to quarterly service charge of "\$61.90" in Section 4.01 thereof, and replacing it with "\$67.50".
- 5. The said by-law is further amended by repealing reference to commodity charge of "\$0.97" in Section 4.02 thereof, and replacing it with "\$1.00".
- 6. The said by-law is further amended by repealing reference to quarterly flat rate commodity charge of "\$67.96" in Section 4.03 thereof, and replacing it with "\$74.76".

BE IT RESOLVED THAT the Council of the City of Fredericton hereby gives By-law No. W-3.21, A By-law Respecting Water Rates and Sewer Rentals, third reading by title.
