# Budget Transfer to award T24-30 Connaught Street to Wright Street Infrastructure Upgrades

#### **Roundabout Maintenance**

Mike Walker, Assistant Director of Engineering and Operations presented a PowerPoint Presentation titled "Parks & Trees – NBDTI Roundabout Maintenance". A copy of the presentation is attached to these minutes as an Appendix.

Highlights of the presentation included a follow up from the July 27, 2023 Municipal Finance & Corporate Administration Committee and the August 21, 2023 City Council meetings whereby a staff direction was given requesting that staff prepare a cost estimate to maintain the roundabouts on provincial highways within the city limits, have a discussion with the Department of Transportation and Infrastructure about cost allocation to maintain same and a direction to bring forward any additional city born costs through to the 2025 budget process.

Mr. Walker provided an overview of cost estimates, the details of his discussions with the Department of Transportation and Infrastructure and noted that further discussion would take place during budget deliberations.
