**THIS AMENDED CONTRACT** made in duplicate as of \_\_\_\_ June, 2021.

**BETWEEN:**

**HOTSPOT PARKING INC.** a body corporate pursuant to the *Business Corporations Act*, SNB 1981, c. B-9.1, having its registered office at 390 King Street, Fredericton, New Brunswick, hereinafter called the "**HotSpot**";

**-AND-**

**THE CITY OF FREDERICTON**, a local government incorporated by virtue of the *Local Governance Act*, SNB 2017, c. 18 having its head office at 397 Queen Street, Fredericton, New Brunswick, hereinafter called the "**City**"

(hereinafter collectively referred to as "the Parties" and individually as a "Party")

**WHEREAS** the Parties entered into a Contract regarding cell phone app to pay electronically for approved parking spaces City-owned parking lots, garages and on-street parking meters on August 13, 2018 ("Contract");

**AND WHEREAS** the Parties agreed to an amendment to the said Contract on December 14, 2018 ("Amendment to Contract");

**AND WHEREAS** the Parties wish to extend the Term of the Contract pursuant to Articles 2.2 and 8.5 of the said Contract;

2. The Contract is hereby extended for further term of one (1) year, commencing on August 13, 2021 and expiring August 12, 2022 (the "Extended Term").
