Title: Appointments to the Planning Advisory Committee

Description:

Council-in-Committee, at its session held on November 22, 2021 considered an administrative report from the Manager of Community Planning which requested Council appoint members to the Planning Advisory Committee.

The Community Planning Act (CPA) stipulates that the composition of PAC’s in the province should consist of members who serve a maximum three-year term. The Act intended that a PAC is structured to have approximately one third of the PAC membership expire every year. As a result, one, two, and three year terms are approved by Council in order to ensure that this rationale is adhered to. The Chairman must be reappointed on a yearly basis and members (Councillors or Citizens) can be reappointed by Council beyond a three year term. It should be noted that the Chair of PAC is appointed by PAC members at the first meeting of the PAC in January.

The three (3) Council Members PAC terms will expire in May of 2022. These specific appointments are reviewed and chosen by the Mayor along with other Committee appointments in accordance with the QMS Governance and Civic Engagement Policy.
